AN ACT

RELATING TO COUNTIES; ELIMINATING PROVISIONS OF LAW PROVIDING FOR INCORPORATED CITY OR TOWN TO JOIN COUNTY LIBRARY SYSTEM; PRESCRIBING POWERS AND DUTIES OF COUNTY BOARDS OF SUPERVISORS IN SUPERVISING COUNTY LIBRARY; ELIMINATING PROVISION OF LAW PRESCRIBING OATH, BOND, DUTIES, COMPENSATION AND EXPENSES OF COUNTY LIBRARIAN; ELIMINATING PROVISION OF LAW PROVIDING FOR TAX LEVY FOR MAINTENANCE OF COUNTY LIBRARY; AMENDING SECTIONS 11-902 AND 11-909, ARIZONA REVISED STATUTES, AND REPEALING SECTIONS 11-903, 11-907 AND 11-912, ARIZONA REVISED STATUTES.

Be it enacted by the Legislature of the State of Arizona:

Section 1. Purpose

The purpose of this act is to clarify the legal right of county and city libraries to exchange books and services for the benefit of the public.

Sec. 2. Section 11-902, Arizona Revised Statutes, is amended to read:

11-902. Notice of proposed establishment of library

A:--The-board-of-supervisors-may-establish-at-the-county-seat-a county-free-library-for-that-part-of-the-county-lying-outside-of-incorporated-cities-and-towns-maintaining-free-public-libraries;-and-for-all such-cities-and-towns-within-the-county-as-may-elect-to-become-a-part of;-or-to-participate-in;-the-county-free-library-system;-as-provided in-this-article;

 $B_{\rm T}$ At least once each week for three successive weeks prior to taking action upon the establishment of the county free library, the board shall publish in the county notice of such contemplated action,

giving therein the date and time of the meeting at which the action is proposed to be taken.

Sec. 3. Section 11-909, Arizona Revised Statutes, is amended to read:

11-909. General supervision; branch libraries

At The county free library shall be under the general supervision of the board of supervisors, which may make general rules and regulations regarding the policy of the county free library, and establish, upon recommendation of the county librarian, branches and stations throughout the county which may be located in incorporated or unincorporated cities and towns when deemed advisable.

B:--The-board-may-determine-the-number-and-kind-of-employees-of the-library;-and-may-appoint-and-dismiss-such-employees-upon-recommendation-of-the-county-librarian:--An-employee-shall-not-be-removed except-for-cause;-and-in-case-a-removal-is-made-upon-the-ground-that the-services-of-the-employee-are-no-longer-required;-the-removed-employee shall-have-the-first-right-to-be-restored-to-employment-when-such-services-are-again-required;-but-the-board-may-at-the-time-of-employing an-employee;-and-upon-the-recommendation-of-the-county-librarian;-enter into-an-agreement-that-the-employee-be-employed-for-a-definite-time-only;
